The contract stipulated that the opposing party was responsible for securing financing. However, they later asserted that the inability to obtain financing was attributed to The Law Office of Cesar A. Montalvo's client. This assertion came after months of payment discussions, culminating in a fraud claim against the client. The Law Office of Cesar A. Montalvo filed a lawsuit, contending that the fraud claim lacked contractual support or evidence.

The company conducted a bench trial, which resulted in the judge ordering the foreclosure of the house, enabling the successful sale of the property and securing the full contract amount, including attorney's fees.
